

Discussion:

It was decided to establish a research forum at the Pillai HOC College of Engineering & Technology with the following aims, objectives and purpose
Organize research seminars of 45 minutes duration by each department every month in hybrid mode and the full text of the paper will subsequently be published after peer review in a journal of the institute or one approved by the UGC.

Subject matter experts from industries, professional societies and other institutes may be inducted to promote inter department - industries - professional societies interaction and collaboration

It was also decided to establish Makers/Skill development/Manufacturing / Idea Labs and CoE in the core competency areas of each department to promote research based teaching and training.

Training seminars, workshops, clinics, internship & Certificate professional development programs for skilling, reskilling, up skilling should be arranged

by departments for the students and industry personnel. This will bridge the skill gap and empower them to meet the requirements of the industries at the shop floor.

Dr. J. W. Bakal, Principal mentioned to encourage faculty and students to file Patent




