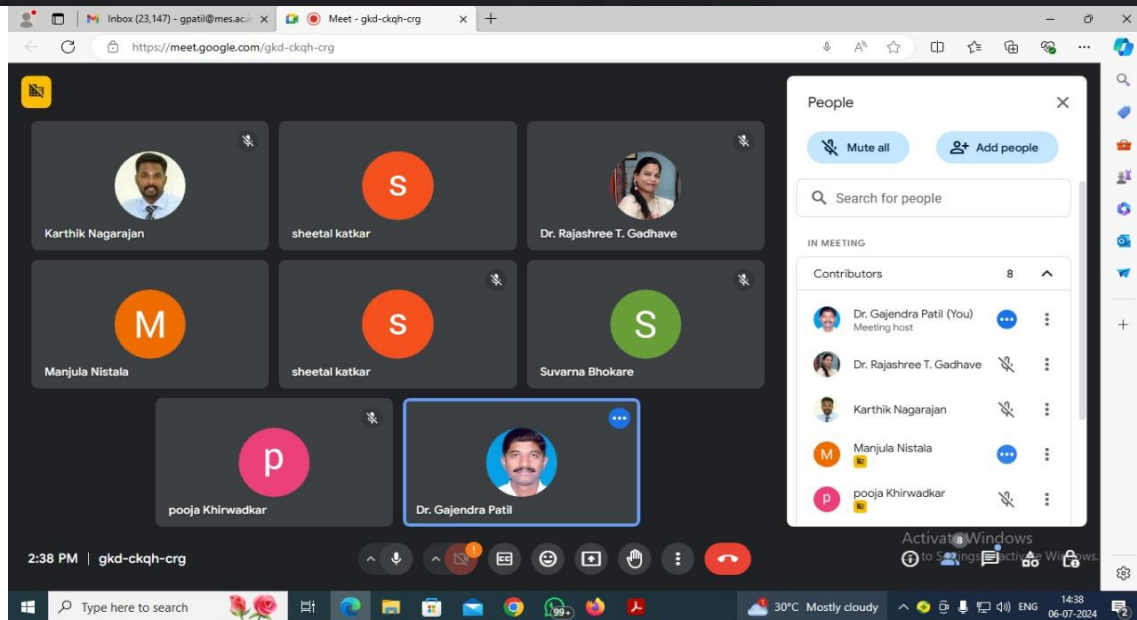
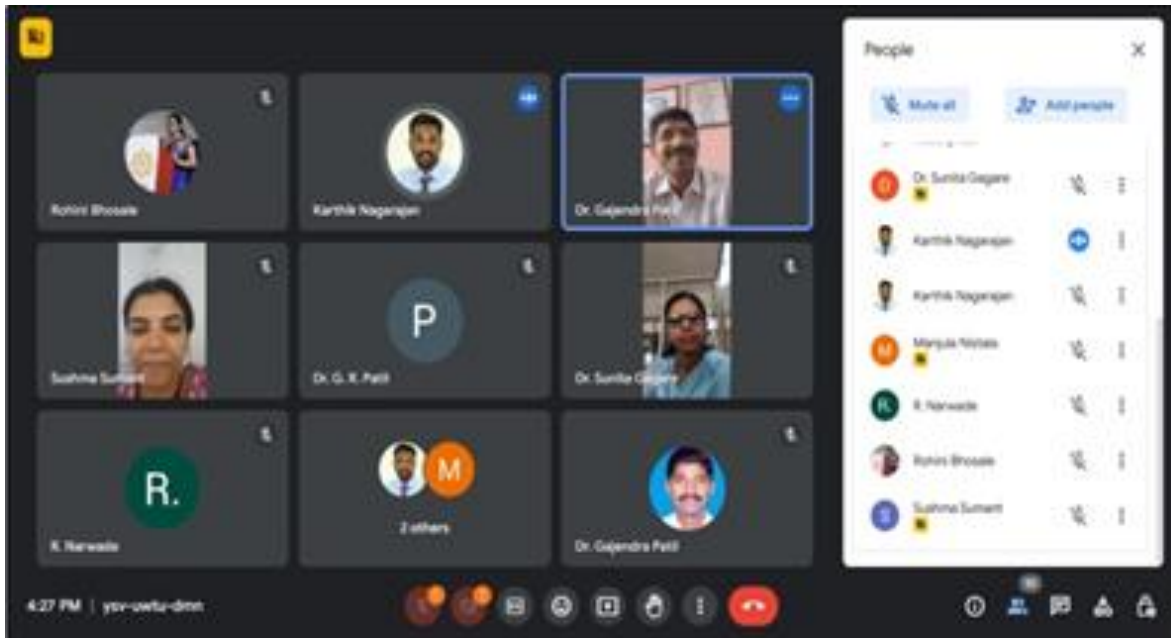
Key Highlights:
