Madam/ Sir,

We are pleased to inform you that your institution is recommended for establishing an AICTE-IDEA Lab with certain stipulations and in Self- Finance mode. AICTE will not provide any type of Financial Support for the establishment of this AICTE- IDEA Lab at your institute.

You have to establish the IDEA Lab within 6 months of acceptance of our offer; and, have to perform the activities and show the performance in the next 6 months. Meanwhile, the IDEA Lab will be admitted in the AICTE-IDEA Lab network and treated at par with the rest of the Labs, including for monitoring. We would like to recall the following to be done by the institution, towards smooth initiation/ implementation of the project.

- Your institution must provide a built-up furnished space of at least 3000 sq. to house the IDEA Lab (2000 sq ft for Lab & 1000 sq ft for student activities; provide equipment/ tools/ consumables worth Rs 80 lakh; and, conduct activities/ events costing Rs. 30 lakh in 2 years (as per Scheme Document); At least Rs. 10 lakh must be spent on activities/ events in the first year.
- Your institution must send its Faculty Coordinator, Faculty Co-coordinators and at least 4 faculties/ technicians (Tech Gurus) to undertake FDPs organized specially for AICTE - IDEA Lab;
- Your institution must have a separate savings bank account for this project, so that expenditure incurred and quantum of revenue generated, aimed at self-sustenance of the Lab is known clearly; and,
- Your institution must abide by Terms and Conditions except Financial Assistance clause given in the Scheme Document; and, observe Code of Conduct for AICTE – IDEA Lab, also given in the Scheme document.

If the Lab is not established in stipulated time and its performance is not found to be satisfactory, the status will be withdrawn and the project would be treated as closed. In such a case, your institution shall not be permitted to use the Name/Logo of AICTE and IDEA Lab in any manner and violation would lead to debarring of grants under other schemes.
